
## From the Territorial Govenor

Howdy all;

I will be heading to the summit in another week. I want to thank everyone that took the time to either email me or talk to me about the TG agenda. This summit has the potential of becoming a turning point for SASS. There are a number of hot issues on the table which could carry repercussions for SASS. Some clubs are preparing to go it alone depending upon the outcome of this summit. The Modification proposal and the Black Powder proposal are adding the most heat to the fire, followed by the B-Western category issue.

The Modification ban, if passed as presented, would not only put an end to any new modifications, but would also force existing modifications to be removed and the gun returned to "out of the box" condition. According to Tex, this includes everything from short stroked 73s to leather wraps on the rifle levers. These things have been acceptable in SASS for the last 25 years. This misguided attempt to stem the modifications race will be nothing less than throwing the baby out with the bath water if passed. Many clubs have already stated that they will not enforce such a rule if passed, and the KRR is one of them. The vast majority of SASS shooters have some type of modification done to at least one of their guns.

Thousands of SASS members have installed thousands of LEGAL modifications costing thousands of dollars. Putting a rule into place that

would force all of these people to remove these modifications and return their guns to "out of the box" condition would serve only to push them away from SASS. Personalizing your guns is part of the fun of this game. This effort to stop the so-called "race guns" war cuts far too deep. Maybe putting a stop to anything from this point forward, or requiring a committee approval might work, but we can not turn back the clock. I am very anxious to see who takes the floor in support of this proposal.

The next big issue is the proposal that I carried forward requiring all shooters in any Black Powder category to "Produce Smoke". This sounds pretty silly on the surface but believe it or not all shooters in the BP categories don't produce smoke! This rule, if passed, would absolutely put an end to anyone shooting illegal duplex loads or loads that put a couple of grains of BP into an ultra short case with a ball on top, thus yielding little or no smoke. Shooting in a BP category and NOT producing smoke gives that shooter a tremendous competitive advantage. The current rules do not state the necessity of the BP shooter to produce smoke. This leaves us with no way to challenge a BP shooter that is not producing smoke. This has simply got to be changed. The BP community, by and large, supports this change. It will however be the large majority of smokeless shooters that determine the outcome of this one.

One other proposal that has generated a great deal of interest is the B-Western category. I feel certain of two things here. First, that there will be a hot debate on it. Many do not want a shooting category based on dress style only. They quote the handbook which says that everyone is already required to meet a dress code, and the B-Western is specifically mentioned. It is a fact that the dress code has not been enforced and has in many cases fallen below what the founders expected. I think we need to find a better way to elevate the dress code. The second thing is this. This category was voted down in the past, but was put into play at the last EOT on a test basis anyway. The biggest promoter of this category is the newest Wild Bunch member and part owner of the Founders Ranch, Coyote Calhoun, SASS #201. He wants it, and since the WB has the power to do anything they want in SASS, I think it will happen.
